

POOL PARTIES

Parties may be reserved any day except Sunday and holidays. Total number of hours for any party is 3. Member is responsible for clearing out non-members after party is over.

One adult swimmer must be present for every five children. If there are 15 or more children, a lifeguard must be secured at your expense.

Adult parties may be reserved on Friday and Saturday nights. Members may use the pool at the time of any pool party; the pool is not for the exclusive use of the booking party.

Party DOES have exclusive use of the covered picnic table area.

Members are responsible for all clean up. If the grounds are not clean, there will be an additional charge, at the discretion of the Board of Directors.

Please contact the Secretary for reservations. A calendar will be posted at the pool with the booking dates entered on it for informational purposes only. The secretary should only make entries. DO NOT use this calendar to make reservations.

These numbers include swimmers and non-swimmers. These numbers do not include pool members, but the total number of people at any pool party, member and non-members total can not exceed 40 people.

- II Children parties must be booked between noon and 6PM.
- III Total number of hours for any party is 3 hours.
- IV Member booking party is responsible for clearing out non-members after party is over. Guests must leave after 3 hours.
- V No more then 8 parties may be booked per week. No parties booked on Sundays or Holidays.
