Agua Linda Rules and Regulations for Pool Use

Updated June 15, 2021

- 1. All facilities of the pool and grounds, including the parking area, shall be used with respect and due consideration for others.
- 2. No person shall swim unless at least one other adult member or adult guest is on the premises; those 16 years or older are considered adults.
- 3. Violation of the rules, boisterous or offensive conduct shall be grounds for temporary expulsion of any person from the pool grounds.
- 4. The lifeguard is responsible for the swimmers in the pool.
- 5. Lifeguards have the authority to enforce pool and safety rules on the entire pool premises. Persons disregarding or disobeying the lifeguards' directives will be reported to the Board; membership privileges may be temporarily or permanently revoked. If problematic behavior involves the children of members or their guests, members will be held responsible.
- 6. The pool is open from 9:00 a.m. until 9:00 p.m. Hours may be shortened at the Board's discretion. No one is allowed in the pool when the pool is closed.
- 7. Tubes, water wings or other toys may be used in the pool when it is not crowded and at the discretion of the lifeguard. They must be clean and shall not be used in the diving area. Rocks and foreign objects must not be thrown into the pool. Beach balls and Nerf balls are permitted when the pool is not crowded.
- 8. No running, wrestling, pushing or throwing in or out of pool or surrounding areas. No spitting in pool or snapping of towels permitted.
- 9. Only one person on the diving board at a time. No jumping off sides of diving board. No cannonballs.
- 10. No diving backwards off the edge of the pool.
- 11. No swimming near diving board when it is in use, due to hazard of divers accidentally striking a swimmer.
- 12. All badges, hairpins, bobby pins, gum, etc. must be removed before entering the pool.
- 13. All trash or recycling must be placed in appropriate bins.
- 14. Only conventional swimwear is acceptable; no outer clothing (cutoffs, etc.) should be worn in the pool.
- 15. No hard liquor allowed within pool property or parking lot. No drinking of alcoholic beverages by persons under the age of 21.
- 16. Persons with symptoms of potential disease (skin rashes, fever, persistent cough, etc.) will not be allowed on pool grounds.
- 17. Persons abusing lawn furniture (upending tables, walking or jumping on loungers, etc.) will be asked to leave.
- 18. Absolutely **NO** glass containers allowed on pool premises. Negligent member is responsible for cleanup and injury.

- 19. Members' children between the ages of 11 and 15 inclusive who can swim may attend the pool without adult supervision, WHEN THE LIFEGUARD IS ON DUTY.
- 20. For the safety of younger children, the pool may be cleared for adults to swim for 15 minute intervals. Adult swim will be called every hour on the hour when lifeguard is present.
- 21. Return chairs and pick up any trash before leaving.
- 22. No eating or drinking (other than water) on pool apron or in rest rooms. No smoking permitted except in parking lot.
- 23. All members are required to sign-in when using the pool.
- 24. No pets allowed within pool premises.
- 25. When pool is being drained, the pool premises must be closed for safety reasons.
- 26. Any of the facilities and equipment lost or destroyed by a member or a guest of a member's family must be replaced or paid for by the member.
- 27. The Agua Linda Swimming Pool Corporation does not assume any liability for injury or loss of personal belongings of any guest or member in the pool grounds or parking area.

Guest Rules

<u>Until further notice</u>, guests are limited to the close family of members--parents/grandparents, children, siblings, nieces/nephews.

Members must stay on the premises with their guest at all times.

Guests are limited to four persons at a time or one family, per member family.

Members are responsible for their guests and their conduct.

Members must register guests upon entering the premises and deposit guest fees in money container provided. *The fee is \$2 per guest*.

Parent authorized babysitters 16 and older, may bring children of members only when the lifeguard is on duty. Parents must attest to the babysitter's status in writing (email is acceptable). Babysitters do not have swimming privileges nor can they bring guests.

When the lifeguard is on duty, member children 11-15 years old who can swim may have one 11-15 year-old or older guests who can swim. Lifeguard may require proof of swimming ability.

POOL PARTIES

<u>Pool parties are suspended until further notice.</u>

Parties may be reserved any day except Sundays and holiday weekends. One adult swimmer must be present for every five children. If there are children, a lifeguard must be secured at your own expense. Agua Linda employed Lifeguard must be secured at a cost of \$30 for 3 hours of party time. Adult parties may be reserved on Friday and Saturday nights. Members may use the pool at the time of the pool party; the pool is not for the exclusive use of the booking party. Party has exclusive use of the covered picnic area and one of the BBQ's. Members are responsible for all cleanup. If the grounds are not clean, there will be an additional charge, at the discretion of the Board of Directors.

Contact the Vice President for reservations. A calendar will be posted on the web with the booking dates entered on it for informational purposes only. Please download the party rules and agreement, fill it out and drop it and your payment to the pool Secretary. Entries on the calendar should only be made by the Secretary. **DO NOT** use this calendar to make reservations.
